- 3) At no time during an organized trip or event may my child use any tobacco product, drink alcohol, use illegal drugs, or carry weapons.
- 4) All bags and rooms are subject to search at any time by an Apex Wrestling School Staff member.
- 5) My child will not leave the means of transportation, hotel or event venue without the permission of an Apex Wrestling School Staff member.
- 6) At no time will my child engage in fighting, cursing, stealing, or any activities that may be regarded as hazing. If they engage in these actions they may be subject to legal repercussion per local and state laws. In addition I may be asked to provide immediate transportation home at my expense, assume full legal repercussions for my child's actions and hold Apex Wrestling School LLC. harmless.
- 7) My child is subject to a curfew to be set by the Apex Wrestling School staff. My child's room will be subject to room checks.
- 8) Apex Wrestling School LLC. reserves the right to revoke any of these rules and guidelines or add to them as it sees fit without notice.
